DEPARTMENT HIGHLIGHTS July 2018

Columbus Police Academy Graduation

On July 6th Chief Greg Jones and Sergeant Garrett Fernander attended the badge pinning ceremony for Officer Steven Persigner at the Columbus Police Academy. The ceremony highlighted Officer Persinger's time at the academy with his classmates with speeches by honorees and the badge pinning for new officers from the City of Columbus and its surrounding suburban agencies. Graduation was held the following day.



Swearing In

On July 17th newly promoted Sergeant Joel Strahler and the department's newest Officers Oren Nauman and Steven Persinger were sworn in by Mayor Sloan Spalding. Retired police sergeant Ed Burton was in attendance, as well as, Newark Police Chief Connell who pinned Officer Nauman. Officer Persinger successfully graduated the Columbus Police Academy and started phase one of field training. Officer Nauman had completed the Columbus Police Academy when he was an officer in Newark, Ohio. Sergeant Strahler assumed duties as third shift sergeant after completing his training early in the month.



Fourth of July Event

The fourth is always a busy day for the men and women of the New Albany Police Department. In the morning, officers worked the Symphony 5k followed by a parade. In the evening, officers worked the festivities leading up to the fireworks. This year the department implemented a new traffic plan to allow event traffic to exit the event area and navigate using detours. The plan worked well and all event traffic was clear within 30 minutes of the fireworks ending.

DEPARTMENT HIGHLIGHTS July 2018

In-Service Training

The training team did an excellent job leading officers during the annual active threat training. Officer Catanese spent a great amount of time with Plain Township Fire Department as they prepared to implement a Rescue Task Force (RTF) response in the event that an active threat would require casualty evacuation. As a result, fire department personnel were integrated into the training. Additionally, command post operations were added giving supervisors an opportunity to practice command, control and coordination using a standardized approach based on Incident Command System (ICS) principles. As a highlight, the training team had volunteer actors play the role of victims and had a medical helicopter land for a practice evacuation.





City-Wide Active Threat Training

Officer Southers and Officer Kelly taught an active threat class to city employees. Over the course of two days, thirty (30) employees were taught basic principles of surviving an active threat encounter.

ALiCE Training

Officer Southers and Officer Kelly also instructed an ALiCE (Alert, Lockdown, Inform, Counter, Evacuate) Active Threat Response class at Homeside Financial. The class was customized and condensed down to approximately an hour to fit within their time constraints. Twenty (20) of their managers attended the class. Officers Southers and Officer Kelly were requested to teach the class to assist with the development of the company's new Emergency Response Plan.

Community Policing

Officer Kelly spent numerous hours on bike patrol in July. While on patrol, he took the opportunity to interact with the kids to encourage bike safety.
