## DEPARTMENT HIGHLIGHTS June 2018

#### Safety Town 2018

New Albany Safety welcomed it's 15th year anniversary this summer. Safety Town has grown from one (1) camp with four (4) sessions teaching eight (8) topics to a two (2) camp option teaching 12 topics. The program has seen significant growth, growing from only 214 campers the first year to reaching a record high of 450 graduates for over a 100% increase in just 14 years. For the past two (2) years Safety Town had to decrease the amount of campers as a result of a shortened summer school season thus allowing enough time for the custodial staff to do what is needed prior to the start of the upcoming school year. Safety Town is now at 400 campers still nearly a 100% increase since inception of the program.

What is also very impressive is the amount of campers that Safety Town attracts from our local communities. Safety Town went from being 100% New Albany residents to being 65% coming from New Albany and the other 35% from our neighboring suburbs. In most recent years Safety Town has up to 45% coming from the greater Columbus suburb communities such as Westerville, Gahanna, Johnstown and Columbus. Safety Town is very proud to support all of our local communities and hopes to continue educating children from the area on "Teaching Our Children to be Safe." Safety Town has invested more into our curriculum as well as into the needs of the Adventureland site. While the camp has added a roundabout in the outdoor learning accompanied by the miniature city market street, Safety Town has added even more into the practical lessons of being safe in and about the home and the community.

Safety Town hopes to develop and change with the community and appreciates the support of many companies and individuals who support the New Albany Safety Town.







## DEPARTMENT HIGHLIGHTS June 2018

#### **Sergeant Promotion**

On June 18, 2018, Officer Joel Strahler was promoted to the position of Sergeant after completing six phases of assessment. Officer Strahler has been with the department 21 years (since 1997). He will assume his new position on July 7, 2018. As a New Albany Police Officer, Sergeant Strahler has served as a school resource officer, canine officer, and a Block Watch advisor.

#### **New Officer**

Jacob Steinbrueck was hired as a new officer and began the Columbus Police Academy on June 18th. Prior to joining the joining the New Albany Police Department, Jacob served as a United States Marine.



#### **Emergency Preparation Exercise**

On June 22<sup>nd</sup> the New Albany Police Department participated in a scenario based training exercise or table top exercise with the Plain Township Fire Department and one of the city's largest businesses. The exercise allowed the group to discuss and evaluate incident command, allocation of resources, communications, lasting presence and areas for improvement.

#### **Drug Investigation**

The New Albany Police Department executed a search warrant related to a drug investigation that began in New Albany. The search warrant was executed with assistance of the Gahanna Police Department. Arrest warrants were issued as a result.

#### **Bike Helmets**

This summer the city has partnered with Johnson's Ice Cream to provide coupons for a free scoop of ice cream to children found wearing a bike helmet while riding their bikes. Officers have been and will continue to handout the coupons throughout the summer. The majority of the coupons have been handed out by officers on bike patrol. It is often more practical for a bike officer to approach children on bicycles. The interaction also is a great chance for the officers to build a positive relationship with the children in the community and the children have an opportunity to see an officer wearing a bike helmet.
