ORDINANCE O-16-2018

AN ORDINANCE AMENDING AND SUPPLEMENTING ORDINANCE NO. 0-10-99 PASSED MARCH 16, 1999, AS AMENDED AND SUPPLEMENTED BY ORDINANCE NO. 0-27-99 PASSED AUGUST 3, 1999, TO MODIFY THE PUBLIC INFRASTRUCTURE IMPROVEMENTS THAT MAY BE FUNDED FROM THE BLACKLICK TIF AND THE DISTRIBUTION OF SERVICE PAYMENTS FROM THE BLACKLICK TIF; AND AUTHORIZING AN AMENDMENT TO THE BLACKLICK TAX INCREMENT FINANCING AGREEMENT

WHEREAS, the New Albany Plain Local School District certified to the City its Resolution No. 99-29 adopted pursuant to Section 5709.40 of the Ohio Revised Code by its Board of Education on March 1, 1999, approving the passage of the Original TIF Ordinance (as defined below) and waiving any notice requirements of Ohio Revised Code Sections 5709.40, 5709.83 and 5715.27 with respect to the Blacklick TIF (as defined below), the passage by the City of legislation related thereto, and the provision of any TIF exemptions in connection therewith, and approved the passage of City legislation related thereto and any TIF exemptions in connection therewith; and

WHEREAS, after providing written notice to the Board of Education of the Eastland-Fairfield Career & Technical Schools (formerly the Eastland Joint Vocational School District) in accordance with Section 5709.83 of the Ohio Revised Code, pursuant to Ohio Revised Code Sections 5709.40, 5709.42 and 5709.43, the City Council on March 16, 1999, passed Ordinance No. O-10-99 (the "Original TIF Ordinance" and, as amended by Ordinance No. O-27-99, adopted August 3, 1999, the "TIF Ordinance") declaring improvements to parcels of certain real property located in the City (as depicted in that Original TIF Ordinance and referred to therein as the "Property") to be a public purpose, exempting those improvements from real property taxation for a period of time, specifying public infrastructure improvements (defined in the Original TIF Ordinance as "Infrastructure Improvements" but referred to herein as "Public Infrastructure Improvements") to be made to benefit those parcels, providing for the making of service payments in lieu of taxes (the "Service Payments") by the "Owners" (as defined in the Original TIF Ordinance) thereof, and establishing a municipal public improvement tax increment equivalent fund into which those Service Payments will be deposited prior to be used to pay costs of those Public Infrastructure Improvements (collectively, the "Blacklick TIF"); and

WHEREAS, in accordance with the Original TIF Ordinance, on July 15, 1999, the Village entered into a Blacklick Tax Increment Financing Agreement (the "TIF Agreement") with The New Albany Company LLC as the then owner of the Property (the "Prior Owner") which, among other things, provided for the development and financing of Public Infrastructure Improvements (defined in the TIF Agreement as "Public Improvements"); and

WHEREAS, as expressly contemplated in the Original TIF Ordinance, on August 3, 1999, the City Council passed Ordinance No. O-27-99 adding additional property to the area subject to the Original TIF Ordinance; and

WHEREAS, on August 9, 1999, the Prior Owner transferred its interest in the Property to Abercrombie & Fitch Co. (the "Company");

WHEREAS, on September 28, 2016, the City and the Prior Owner entered into a First Amendment to the Blacklick Tax Increment Financing Agreement modifying the description of Public Infrastructure Improvements that may be funded from the Blacklick TIF; and

WHEREAS, the City desires to further amend the TIF Ordinance and the TIF Agreement to further modify the Public Infrastructure Improvements described therein and adjust the distribution of monies from the Building Account in the Blacklick TIF Fund (both as referred to and defined in the Original TIF Ordinance; and

WHEREAS, the New Albany Plain Local School District by Resolution No. 99-29 adopted by its Board of Education on March 1, 1999, waived any notice requirements of Ohio Revised Code Sections 5709.40, 5709.83 and 5715.27 with respect to the Blacklick TIF, the passage by the City of legislation related thereto, and the provision of any TIF exemptions in connection therewith, and approved the passage of City legislation related thereto and any TIF exemptions in connection therewith; and

WHEREAS, this Council finds and determines that notice of this proposed Ordinance has been delivered to the Board of Education of the Eastland-Fairfield Career & Technical Schools (formerly the Eastland Joint Vocational School District) in accordance with Section 5709.83 of the Ohio Revised Code and hereby ratifies the giving of that notice;

NOW, THEREFORE, BE IT ORDAINED by Council for the City of New Albany, Counties of Franklin and Licking, State of Ohio, that:

Section 1. Amendment to Section 2 of Original TIF Ordinance. Section 2 of the Original TIF Ordinance is amended and restated as follows: "The public infrastructure improvements to be made by the City include the public infrastructure improvements (in each case, together with all necessary appurtenances) described in attached <u>Exhibit A</u> that directly benefit, or that once made will directly benefit, the Property and all other public infrastructure improvements and related appurtenances that are designated as those public infrastructure improvements that directly benefit, or that once made will directly benefit, the Property (the "Infrastructure Improvements")." Exhibit A attached to this Ordinance shall be attached to the TIF Ordinance.

Section 2. Amendment to Section 3(b) of Original TIF Ordinance. Section 3(b) of the Original TIF Ordinance is amended and restated as follows: "The portion of any service payment relating to the building value, to the extent not otherwise exempt from taxation pursuant to the CRA statute, of a parcel (as determined by the Franklin County Auditor's office) will be deposited into the Building Account (as defined herein) for further distribution, within thirty (30) days of receipt by the City (formerly referred to as the Village), to the following: (i) the School District, (ii) the Eastland-Fairfield Career & Technical Schools (formerly the Eastland Joint Vocational School District), and (iii) the Plain Township Fire Department. The service payments distributed pursuant to this Section 3(b)(i) and (ii) shall be in the same amounts the School District and the Eastland-Fairfield Career Centers would have received if each Parcel in respect of which the service payment was made was not exempt from taxation pursuant to the TIF Ordinance. The payment to the Plain

Township Fire Department shall be in amount to be determined. The balance of the service payments remaining in the Building Fund after the distributions of those service payments provided in the prior three sentences shall be applied by the City to the payment of costs of Public Infrastructure Improvements."

Section 3. TIF Agreement Amendment. The Second Amendment to the Blacklick Tax Increment Financing Agreement (the "TIF Agreement Second Amendment"), by and between the City and the Former Owner, in the form presently on file with the Clerk of Council, revising the description of the Public Infrastructure Improvement consistent with Section 1 of this Ordinance, is hereby approved and authorized with any changes therein not inconsistent with this Ordinance and not substantially adverse to this City and which shall be approved by the City Manager. The City Manager, for and in the name of this City, is hereby authorized to execute that TIF Agreement Second Amendment with the character of any changes thereto being consistent with this Ordinance and not substantially adverse to the City, evidenced conclusively by the execution thereof.

Section 4. Further Authorizations. This Council further hereby authorizes and directs the City Manager, the Director of Law, the Director of Finance, the Clerk of Council, or other appropriate officers of the City to prepare and sign all agreements or other instruments and take any other actions as may be appropriate to implement this Ordinance and the transactions referenced or contemplated in this Ordinance and in the TIF Agreement Second Amendment.

Section 5. Open Meeting. It is hereby found and determined that all formal actions of this council concerning and relating to the passage of this ordinance were adopted in an open meeting of the council and any decision making bodies of the City of New Albany which resulted in such formal action were in meetings open to the public or in compliance with all legal requirements of the City of New Albany, Counties of Franklin and Licking, State of Ohio.

Section 6. Effective Date. Pursuant to Article VI, Section 6.07(B) of the Charter of the City of New Albany, this ordinance shall be in effect on and after the earliest period allowed by law.

<u>Exhibit A</u>

Public Infrastructure Improvements

- A. A public road extending easterly from Johnstown Road (U.S. 62) across Kitzmiller Road and across Blacklick Creek, and continuing easterly until it curves southerly to intersect with S.R. 161 and the affected intersections;
- B. The public roadways constituting the widening of Johnstown Road (U.S. 62) north of S.R. 161, including the rerouting of Bevelheimer Road and its connection to Johnstown Road (U.S. 62);
- c. The Blacklick Sanitary Sewer serving the Blacklick Business Campus;
- D. The Blacklick Sanitary Truck Sewer extension/S.R. 161 crossing (extension of approximately 2,200 feet of 35-inch sanitary sewer from the north side of Smith's Mill Road, south along the Franklin/Licking Count line);
- E. Blacklick Water Line extension / S.R. 161 crossing (extension of approximately 3,000 feet of 24inch water main along Beech Road NW from the intersection with Smith's Mill Road, south through S.R. 161 interchange);
- F. Installing a leisure trail and velo-loop along Smith's Mill, Kitzmiller, and Central College Roads;
- G. Resurfacing of Smith's Mill Road;
- H. Extension of Evans Road connecting the south end of Evans Road to an existing parking lot, or a suitable alternative mutually agreed upon by the City and Abercrombie & Fitch;
- Construction of a new right turn lane, leisure trail path, and related improvements along Smith's Mill Road and the construction of an additional vehicular turn lane along Fitch Path on the Abercrombie & Fitch campus;
- J. Widening and extension of an access drive on the Abercrombie & Fitch campus drive to accommodate vehicular stacking and to allow a right-only egress lane, together with any necessary easements to the City therefor;
- **K.** Construction of an approximately 4' by 12' bus shelter and related improvements at a location mutually agreed upon by the City and Abercrombie & Fitch;
- L. Extension of Innovation Campus West Road to the A&F Campus;
- M. Improvements to S.R. 161 exit and entrance ramps at U.S. 62;
- N. Modification of traffic control devices at the intersection of Beech Road NW and Innovation Campus Way;
- Haines Ditch and Blacklick Creek restoration and maintenance; (m) Kitzmiller Road/Smith's Mill Road intersection improvements, extending Ganton from U.S. 62 east and through existing Kitzmiller/Dubin-Granville intersection;
- P. Widening of Dublin-Granville Road, east of Kitzmiller Road to Beech Road NW, including related utilities and affected intersection.;
- Q. Landscape improvements along Smith's Mill Road between Beech Road NW and Franklin/Licking County line including road island.;
- R. A new public road and public utilities to serve ± 95-acre development at southwest corner of Beech Road NW and Smith's Mill Road;
- s. Construction of a north/south road through the Strauss property, with all necessary utilities;
- T. Providing for traffic signalization at Smith's Mill Road and Forest Drive; and
- U. Central College and Jug Street road improvements from U.S. 62 to Beech Road, including paving and installation of leisure trails, waterlines and fiber optic lines, and City acquisition of an easement therefor.

RESOLUTION R-25-2018

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A COLLECTIVE BARGAINING SUCCESSOR AGREEMENT WITH THE FRATERNAL ORDER OF POLICE, CAPITAL CITY LODGE #9 REGARDING WAGES, HOURS, TERMS AND CONDITIONS OF EMPLOYMENT FOR SWORN OFFICERS BELOW THE RANK OF SERGEANT

WHEREAS, the City of New Albany ("City") and the Fraternal Order of Police – Capital City Lodge No. 9 ("Lodge") are parties to a Collective Bargaining Agreement effective June 2, 2015 through December 31, 2017 ("Agreement"); and

WHEREAS, the City and the Lodge have reached tentative successor agreement for a Collective Bargaining Agreement ("Successor Agreement") regarding wages, hours, terms and conditions of employment for full-time sworn officers below the rank of sergeant; and

WHEREAS, Council has determined that the Successor Agreement between the City and the Lodge which represents the bargaining unit employees (all full-time police officers below the rank of sergeant), should be ratified.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of New Albany, Counties of Franklin and Licking, State of Ohio, that:

Section 1. Council authorizes the city manager to enter into the Successor Agreement with the FOP regarding wages, hours, terms and conditions of employment for all full-time police officers below the rank of sergeant.

Section 2. This Successor Agreement shall supersede and replace all applicable state and local laws, which it has the authority to supersede and replace.

Section 3. It is hereby found and determined that all formal actions of this council concerning and relating to the adoption of this resolution were adopted in an open meeting of the council, and that all deliberations of the council and or any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121 of the Ohio Revised Code.

Section 4. Pursuant to Article 6.07 of the New Albany Charter, this resolution shall take effect upon adoption.
