DEPARTMENT HIGHLIGHTS September 2018

A&F Challenge

Officers provided security for the 2018 A&F Challenge on September 7th. The event proceeds benefited SeriousFun Children's Network, a global network of camps and programs for kids with serious illnesses and their families. They were able to raise over \$3.7 million, translating to 1,500 camp experiences for the kids.

Block Watch

The Cedarbrook group held their Block Watch picnic on September 23rd. The picnic was held on Cedarbrook and well over eighty residents attended. Officer Oren Nauman served as the grill



master serving burgers, brats and hot dogs. Officers discussed safety tips, calls for service in the residential areas and also addressed speeding complaints in the residential community. Plain Township was also in attendance giving tours of their trucks.



Officers also attended a neighborhood block gathering in the Lambton Park neighborhood. Officers

reported a good turnout for the event and were present to meet and greet residents and discuss concerns.



DEPARTMENT HIGHLIGHTS September 2018

Honors

On September 23, 2018 Officer Kelly attended the "Faith and Freedom" church service at Franklin Church on Central College Rd. The service honored the sacrifices made by police officers. The agency was presented a certificate of appreciation. Representatives from Dublin PD, Clinton Township PD, Danville PD and Kirkersville PD were also present.

Officer Compliments

Officers Hamilton and Nauman were both complimented on separate incidents. One individual called to say thank you to Officer Nauman for going "above and beyond" while unlocking a vehicle. Officer Hamilton was complimented during a traffic stop for how "professional" and "helpful" he was.



On September 26, 2018 Officer Kelly, Officer Rehnert and Probation Officer Boyd conducted a Rape Aggression Defense (RAD)/female self-defense and safety talk to the Women's Worship Group at the Church of Latter Day Saints on Central College Rd.

Bike Ride

On September 29, 2018 Officer Southers assisted with the city-sponsored community bike ride that started and ended at the Rocky Fork Metro Park. The bike ride traveled through the New Albany Links subdivision and Bevelhymer Park.

Public Safety Day

On September 29, 2018 Officer Kelly attended the Licking County Public Safety Day at OSU-Newark. Every Licking County law enforcement agency as well as CPD helicopter, Newark Fire, and Air Evac medical helicopter attended and interacted with the public who stopped by.

Thefts

The community experienced an increase in thefts during the month of September. The agency worked with several other local agencies to identify a suspect. NAPD was first to issue warrants for the suspect, Bradley Green, who was subsequently arrested by the Columbus Police Department. Similar crimes have since decreased.

DEPARTMENT HIGHLIGHTS September 2018

Bike Helmets and Ice Cream

This past summer, the city partnered with Johnson's Ice Cream to provide free ice cream coupons to children found wearing a bicycle helmet while riding their bikes. The majority of the coupons were handed out by bike officers. The program ended for the summer on September 30th and 225 coupons have been redeemed for free ice cream. We again want to thank Johnson's Ice Cream for their partnership and their efforts to help promote safety in New Albany.

Wearing helmets can reduce the risk of a head injury by up to 85% and 75% of all fatal cycling accidents involve a head injury. Facts like those is what lead the City of New Albany to enact a bike helmet law in March of 2016. The law requires all riders under 18 years old to wear a bike helmet. The intent was to save lives by creating better habits. The cities efforts to promote bicycle safety dates back over ten years when the safety town program began and children attending were provide free helmets and learned the importance of wearing them while riding.

Drug Drop Box

The City of New Albany offers the community an opportunity to dispose of unneeded prescription medications. In the department's lobby (open 24 hours a day/7 days a week) is a prescription drug disposal box. Citizens can bring in unwanted medications and the department will have them destroyed at no expense to the public. Only pills, including blister packs, can be submitted currently (no syringes, liquids, illicit drugs, etc.). The department has collected 142 pounds of prescription pills since the program's inception in 2017. This program aides in curbing the potential for the abuse of opioids/pain management medications.

Personnel Updates

Sergeant Strahler

Sergeant Joel Strahler, who was promoted earlier this year, has begun the Law Enforcement Foundation's Supervisor Training and Education Program (STEP). The program is comprised of nineteen modules completed during three week long segments.

New Officers

The city has several new officers who are in different stages of beginning their law enforcement career. Officer Steven Persinger has completed the police academy and is currently in the last phase of his field training. He is anticipated to complete his field training in October. Officer Jacob Steinbrueck is currently attending the Columbus Police Academy and will be graduating near the end of the year. Lastly, three officer applicants have accepted conditional job offers. If they successfully complete the remaining tests they will likely start the police academy in December.

Dispatcher

The background investigations of several dispatcher applicants was complete along with applicant interviews. The hiring process is anticipated to be completed in October with successful applicant(s) beginning their training by the end of the year.
