

KITZMILLER WETLAND PARK VISION OCTOBER 2021

ACTIVE DESTINATION PARK

This plan depicts proposed improvements for the Kitzmiller Wetland Park. These schematic designs are conceptual and provide a vision of how the park could be developed to meet the goals and recommendations found in the 2021 Parks Framework Plan.

The Kitzmiller Park is currently categorized as a parkland preserve and destination park in the Parks Framework Plan. Surveys completed for the development of the Parks Framework Plan identified a community desire for more active recreational equipment; accordingly, this vision demonstrates that the preservation and access to natural resources via trails and boardwalks can coexist on a site with robust active recreational activities. Wetlands, mature tree stands, and prairies currently cover a majority of the site. These great natural assets will be preserved while the upland portion is utilized to consolidate active hardscape elements like a destination playground, the city's first skatepark, various sport courts, a pavilion, and parking.

This custom playground will be the attraction for school-aged kids. Large-scale custom play equipment, nature play and a gracious sloped lawn with embankment slide will keep children busy all afternoon.

Tweens and teens will enjoy a skatepark that is sized and programmed to accommodate regional visitors at all skate levels. Additionally, and in step with New Albany's dedication to sustainability, the skatepark will be designed in harmony with its ecological surroundings and with stormwater mitigation strategies and plantings.

Parents will love the trellis shade structure, pavilion/restrooms, and parking in close proximity to the playground, skatepark, and trailheads. Families can find a convenient place to post up in the morning and stay busy until sundown.

Three parcels along Kitzmiller Road were acquired through Clean Ohio. These parcels have restrictions on site usage and development. The declaration of these restrictions for these three parcels specifically state:

- days per year.

Based on initial research, the entry drive, parking and pavilion shown in this plan are acceptable improvements within these restricted parcels.

The city, in perpetuity, shall maintain the property as passive parkland or greenspace. • The property, once converted to passive parkland, shall be open to the public 365

Improvement types and amenities are limited to passive activities.


