DEPARTMENT HIGHLIGHTS February 2017

Citizen Police Academy Program

February 1st was the first night of the 2017 New Albany and Gahanna Police Department's Citizen Police Academy. The academy is a ten week program and it began with a tour of both police facilities. The topics covered during the February classes included the school resource officer, traffic and OVI enforcement, laws of arrest of arrest and search and seizure.

2016-2017 Deer Management Program

The New Albany Deer Management program ran from September 24, 2016 through February 5, 2017. Of the 99 hunters who were eligible for the program, 62% of them were active during the program season. Forty one deer were harvested during this year's program, eight more than last year. Thirty seven of the harvested deer were does and four were bucks. Three hunting zones were added this year and all of the hunting zones from last year were available this year. The deer management program helps to thin the deer population within the city and reduce the chances for car vs deer accidents.

Compliments

The department received two compliments regarding Officer Klingler's work. The first compliment was from a woman that Officer Klingler pulled over for a traffic violation. She told him that she was taking her ill grandmother to the hospital because her grandmother would not allow her to call a medic. Officer Klingler had medics respond to the traffic stop location and the grandmother was transported to the hospital. The woman stated she appreciated Officer Klingler's help and that he saved her grandmother's life.

The second compliment was from a woman whose car had broken down on the freeway. She wrote "Thank you for stopping this last Friday night to check on me. The tow company did get me all fixed up, but the flares that you put out was an item that I have never thought of carrying. Thanks again, it was nice for you to stop and make sure everything was ok and express interest that I was safe."

Symposium

Officers Nemeth, Kelly and Southers attended Avielle Foundation symposium at the Phil Heit Center for Healthy New Albany on Thursday, February 23rd, 2017. The presenter for the evening was Dr. Jeremy Richman, who lost his daughter Avielle during the Sandy Hook school shooting. Dr. Richman's presentation was titled "The Science of Violence & Compassion". Dr. Richman studies brain science and the impact of behavioral and environmental factors associated with an individual's global functioning.

Life Saving Call For Service

Officer Rehnert responded to a call of a female choking after he was alerted by Dispatcher Anita Mercer of the 911 call for medics. Officer Rehnert was near the location and upon his arrival administered a shock from his cruiser's AED and performed CPR. He was ultimately relieved by medics and after approximately thirty minutes of life saving efforts she began breathing on her own. She was transported to the hospital and expected to make a full recovery.

Computer Aided Dispatch and Records Management System

For approximately a year the police department has been working to transition to a new Computer Aided Dispatch and Records Management System. The current system has been in use for over fifteen years. In preparation for the March switch date, all department members have been receiving extensive training in use of the new system. The new system will allow the department to streamline many processes, gather additional and better information, and allow the officers to complete more of the work in their cruisers.

Dispatcher Training

The department's newest dispatcher, Lindsey Allen, has passed her emergency communications training and is working her new schedule. Dispatcher Allen proved to be a quick learner and performed very well during her training.

DARE Graduation

On February 2, 2017 DARE Officer Kelly held the DARE graduation of his 5th grade classes at the McCoy Center for the Performing Arts. K9 Officer Alex Coles of the Pataskala Police Department provided the students with an excellent police K9 demonstration. The demonstration was impressive and the students loved the dog's personality.
