Police Rescue

On 6/6/2019, Officer Conn and Officer Hall were dispatched to 1 Club Lane on a report of an unconscious person with CPR being performed. Both officers arrived at the same time and found the person in the workout room of the bath and tennis building. CPR was still being performed by another member of the club. Officer Hall hooked up our AED and it advised to shock. After the shock was delivered, Officer Conn continued CPR. Plain Township medics arrived quickly and the patient was transported to the hospital where he recovered.

Click it or Ticket

The department participated in the National Highway Transportation Administration's Click it or Ticket initiative. This national enforcement mobilization began May 20th, 2019 and lasted through June 2nd, 2019 and focuses on creating focused traffic enforcement in an effort to increase public safety. In addition, officers track stops involving impaired motorists, speed violations and felony arrests. New Albany officers made 138 traffic stops across the two week initiative. Officers made 3 arrests for driving while impaired, cited 13 drivers for speed violations and made 1 felony arrest. In addition, 12 motorists were cited for driving with suspended driver's licenses and 6 were cited for safety belt violations.

Bike Helmet Ice Cream Coupon Campaign

All Officers are participating in the ice cream coupon campaign in conjunction with Johnson's ice cream. Officers are giving coupons to children who are found wearing their bike helmets. This is the second year the department has handed out the coupons. Last year, hundreds of coupons were redeemed for ice cream. Thanks again to Johnson's Ice Cream for partnering with the city to promote bicycle safety.

III. Activity Detail

Along with Chief Jones and Sergeant Fernander, I was privileged to attend the 142nd Basic Peace Officer School Graduation Exercises of the Ohio Highway Patrol Academy to celebrate our new officers Chase Blankenship and Codey Ratliff. It was a pleasure to meet family and friends who were on hand to congratulate them on their achievement.

Participated in the June 19 Plain Township Fire Department Dedication Ceremony for new Ladder 121 where I offered a prayer of blessing. Members of the community, neighboring fire departments, and community leaders were invited to the ceremony. After the blessing of the truck, Chief Hoovler sprayed down the new ladder, then attendees were invited to help firefighters dry the truck and push it back into the station. Ladder 121 was officially placed in service on June 27.

Served as chaplain at a retreat held June 28-30 for Ohio first responders (police, fire, dispatch) and their significant others who have been impacted by critical incidents. The retreat was hosted by The Bridge, a non-profit made up of first responders who have experienced traumatic events firsthand and clinicians experienced in counseling first responders.

At the June meeting of the Central Ohio Law Enforcement Chaplains Team (COLECT), I was honored to be elected to serve on the Board along with Jim Meacham (Westerville PD), Andy Burns (Mt Vernon PD), and Steve Norden (Dublin PD). COLECT is comprised of approximately 35 central Ohio LE chaplains representing more than a dozen agencies with the goals of providing chaplain mutual aid between agencies and fostering support and training.
