

#### **ORDINANCE 0-42-2025**

# AN ORDINANCE TO ACCEPT THE EXPEDITED TYPE 1 ANNEXATION OF 2.0 +/- ACRES FROM JERSEY TOWNSHIP, LICKING COUNTY TO THE CITY OF NEW ALBANY

WHEREAS, pursuant to the petition filed by Underhill & Hodge, LLC, agents for petitioner, with the Licking County Commissioners, on August 19, 2025, and

WHEREAS, the foregoing Resolution #25-0709-COMM, dated August 28, 2025 and as corrected on September 2, 2025, of the Licking County Commissioners granting the petition was delivered to the City of New Albany on September 9, 2025, and more than sixty (60) days have elapsed since the foregoing resolution and transcript was transmitted to the City of New Albany, and

WHEREAS, pursuant to the Road Maintenance Agreement between the City of New Albany and the Township of Jersey signed on July 22, 2022 and authorized by R-20-2022, the City of New Albany assumed responsibility for the maintenance and improvements of the section of Beech Road impacted by this annexation, and

WHEREAS, pursuant to New Albany Codified Ordinance 1125.05, all newly annexed areas shall immediately be zoned into the Agricultural District and shall be subject to the regulations and restrictions pertaining thereto, and

WHEREAS, the real estate is located in Licking County and is subject to the "New Albany East Community Authority" and subject to a special property assessment in compliance therewith, and

WHEREAS, New Albany City Council has determined that annexation of the real estate is in the best interests of the residents of the City of New Albany.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of New Albany, Counties of Franklin, and Licking, State of Ohio, that:

Section 1. The application of property owners set forth in Licking County requesting the annexation of 2.0 +/- acres, which is contiguous to the City of New Albany, is hereby accepted, and the corporate boundaries of New Albany shall be extended to include the territory, more particularly described in Exhibit A, attached hereto and incorporated herein as if fully written.

Section 2. An accurate map of the territory attached as <u>Exhibit B</u>, the petition for its annexation, other related documents, and a certified transcript of the proceedings of the Licking County Board of Commissioners regarding the annexation proceedings have been on file with the

Clerk of Council of the City of New Albany for sixty (60) days prior to being presented to this Council as required by law, and are hereby accepted.

**Section 3.** Council of the City of New Albany hereby accepts the annexation of a 2.0 +/- acre tract, situated in Jersey Township, Licking County, Ohio, the same being land of the owners set forth above, for annexation to the City of New Albany.

**Section 4.** The clerk is herewith directed to deliver certified copies of this ordinance and other proceedings relative to the annexation to the County Auditor, County Recorder, and the Secretary of State.

Section 5. It is hereby found and determined that all formal actions of council concerning and relating to the adoption of this legislation were adopted in an open meeting of council, and that all deliberations of the council and or any of its committees that resulted in such formal action were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

Section 6. Pursuant to Article VI, Section 6.07(B) of the City of New Albany Charter, this ordinance shall be in effect on and after the earliest period allowed by law.



#### **ANNUAL APPROPRIATION ORDINANCE**

AN ORDINANCE TO MAKE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF NEW ALBANY, STATE OF OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2026

WHEREAS, Council for the City of New Albany, State of Ohio, wishes to fund the city's current expenses and other expenditures during fiscal year 2026.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of New Albany, Counties of Franklin and Licking, State of Ohio, that:

Section 1. To provide for the current expenses and other expenditures within the 2026 Annual Budget Program of the City of New Albany during the fiscal year ending December 31, 2026, the annual sums as follows are hereby set aside and appropriated:

Section 2. To affect the purposes of the foregoing appropriations, the city manager is authorized to enter into agreements on such terms determined in the city manager's discretion, consistent with all other ordinances and resolutions in effect and enacted from time to time.

Section 3. The director of finance is authorized to allocate the appropriations for a department within activities. Except as provided in Section 4, Section 5, and Section 6, the director of finance is authorized to approve transfers between activities, provided that funds may not be transferred between appropriation line items.

Section 4. The director of finance is authorized to transfer up to \$10,000 per quarter between appropriation line items, provided that such transfers are within the same fund and department, where applicable.

Section 5. The director of finance is authorized to transfer appropriations between the General Fund and various special revenue funds, which include the Police and Mayor's Court departments, provided that such transfers are for an expense that meets the restrictions of the said fund or funds, where applicable.

**Section 6.** The director of finance is authorized to transfer appropriations between the Public Service and Land & Buildings Maintenance budget departments as needed while operating under a single Public Service department.

**Section 7.** It is hereby found and determined that all formal actions of this council concerning and relating to the adoption of this legislation were adopted in an open meeting of council, and that all deliberations of the council and or any of its committees that resulted in such formal action were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

Section 8. Pursuant to Article VI, Section 6.07(A) of the Charter of the City of New Albany, this ordinance shall be in effect on and after the earliest period allowed by law.

#### **RESOLUTION R-40-2025**

A RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF AN AMENDED AND RESTATED COMMUNITY REINVESTMENT AREA AGREEMENT WITH DISTRIBUTION LAND COMPANY, LLC, AND MAKING RELATED AUTHORIZATIONS

WHEREAS, Distribution Land Company, LLC (fka Distribution Land Corp.) (an affiliate of Bath & Body Works, Inc.) with offices located at Three Limited Parkway, Columbus, OH (the "Company"), previously acquired property (the "Project Site") in the City of New Albany for the potential construction of office and warehouse buildings and related site improvements (the "Original Project"). In support of the development of the Original Project, the City and the Company entered into a Community Reinvestment Area Agreement dated March 11, 2014 (the "Original CRA Agreement") pursuant to City Resolution No. R-17-2014 adopted on March 4, 2014; and then a Supplemental Agreement (the "Supplemental Agreement") dated September 9, 2019, was entered into by the City and the Company pursuant to City Resolution No. R-03-2018 adopted on January 16, 2018.

WHEREAS, the City and the Company intend to amend and restate the Original CRA Agreement as amended by the Supplemental Agreement to make the agreement more consistent with recent CRA agreements for distribution center projects in the City; and

WHEREAS, Council previously created the current Oak Grove II Community Reinvestment Area by its Resolution No. R-17-09 adopted March 3, 2009, as supplemented by its Resolutions No. R-41-10 adopted July 6, 2010, No. R-72-10 adopted November 16, 2010, No. R-53-12 adopted October 12, 2012, No. R-26-13 adopted July 16, 2013, No. R-72-14 adopted September 9, 2014, No. R-49-2015 adopted November 17, 2015, No. R-45-16 adopted November 1, 2016, No. R-02-17 adopted February 7, 2017, No. R-17-18 adopted July 17, 2018, No. R-41-18 adopted November 6, 2018, No. R-05-2019 adopted February 19, 2019, No. R-37-2019 adopted August 6, 2019, No. R-15-2021 adopted April 6, 2021, No. R-46-2021 adopted September 21, 2021, No. R-09-2022 adopted February 1, 2022, No. R-18-2022 adopted May 3, 2022, No. R-38-2022 adopted November 15, 2022, No. R-21-2023 adopted April 18, 2023, No. R-46-2023 adopted November 7, 2023, and No. R-25-2025 adopted July 15, 2025; and

WHEREAS, the City's Housing Officer, duly designated under Ohio Revised Code Section 3735.65, has reviewed the proposal to amend and restate the Original CRA Agreement has amended by the Supplemental Agreement and has recommended that City Council approve the proposal on the basis that the Company is qualified by financial responsibility and business experience to create and preserve employment opportunities in the Area and improve the economic climate of the City; and

WHEREAS, the City, having the appropriate legal authority, desires to provide certain property tax incentives to encourage development of the Project; and

WHEREAS, the Boards of Education of the Johnstown Monroe Local School District, Licking Heights Local School District and the Licking County Joint Vocational School District (also known as "Career and Technology Education Centers of Licking County" or "C-TEC") have all waived their rights to (i) receive notice of the Amended and Restated Community Reinvestment Area Agreement under Ohio Revised Code Sections 3735.671 and 5709.83, and (ii) approve the Amended and Restated Community Reinvestment Area Agreement; and

**NOW, THEREFORE, BE IT RESOLVED** by Council for the City of New Albany, Counties of Franklin and Licking, State of Ohio, that:

- Section 1. Amended and Restated Community Reinvestment Area Agreement. The Amended and Restated Community Reinvestment Area Agreement by and between the City and the Company, in the form presently on file with the Clerk of the Council, is hereby approved and authorized with any changes therein and amendments thereto not inconsistent with this Resolution and not substantially adverse to this City and which shall be approved by the City Manager. The City Manager, for and in the name of this City, with the advice of the Director of Law, is hereby authorized to execute the Amended and Restated Community Reinvestment Area Agreement and approve the character of any changes and any amendments thereto as consistent with this Resolution and not substantially adverse to the City, as evidenced conclusively by his execution of the Amended and Restated Community Reinvestment Area Agreement.
- Section 2. Further Authorizations. Council further hereby authorizes and directs the City Manager, the Director of Law, the Director of Finance, the Community Development Director, the Clerk of Council, or other appropriate officers of the City to prepare and sign all agreements and instruments and to take any other actions as may be appropriate to implement this Resolution and the transactions referenced or contemplated in this Resolution, including the Amended and Restated Community Reinvestment Area Agreement as approved in this Resolution.

A RESOLUTION TO AUTHORIZE THE CITY MANAGER TO PARTICIPATE IN CONSORTIUM CONTRACTS FOR REQUIRED SERVICES AND A BID FOR THE COLLECTION, TRANSPORTATION, AND DELIVERY FOR DISPOSAL AND/OR PROCESSING OF RESIDENTIAL SOLID WASTE, RECYCLABLE MATERIALS, YARD WASTE, AND ORGANIC MATERIALS GENERATED WITHIN THE CITY OF NEW ALBANY, OHIO

WHEREAS, pursuant to Section 715.43 of the Ohio Revised Code, the city may establish such collection systems and solid waste facilities as may be necessary or appropriate to provide for the safe and sanitary management of solid waste, including recyclable materials, yard waste, and organic materials generated within the City of New Albany; and

WHEREAS, the City of New Albany and other central Ohio communities have determined that, to foster competition and secure experienced waste collection, disposal and processing services, bidding together as a consortium is desirable; and

WHEREAS, the City of New Albany has determined that it may be in the best interests of its residents that the city arrange for the collection, transportation and delivery for disposal and/or processing of all solid waste, recyclable materials, yard waste, and organic materials generated at residential units and municipal facilities located within the City of New Albany from a single contractor on an exclusive basis ("Collection Services"); and

WHEREAS, the city's current Collection Services Agreement will expire at the conclusion of the existing term on December 31, 2026, and it is necessary to participate in the 2026 SWACO Consortium bid process to ensure continued uninterrupted recycling and collection services beginning January 1, 2027; and

WHEREAS, the council of the City of New Albany desires to authorize the city manager to take all necessary actions to advertise, receive, and evaluate bids through the consortium for the provision of collection and processing services, and to bring forward a recommendation for contract award consistent with the city's procurement procedures.

**NOW, THEREFORE, BE IT RESOLVED** by Council for the City of New Albany, Counties of Franklin and Licking, State of Ohio, that:

Section 1. The city manager is hereby authorized to participate in advertisement and bid for the collection, transportation and delivery for disposal and/or processing of residential solid waste,

#### **RESOLUTION R-42-2025**

A RESOLUTION TO AMEND THE CITY'S GROUND LEASE WITH THE NEW ALBANY PLAIN LOCAL JOINT PARK DISTRICT TO PROVIDE FOR THE DEVELOPMENT AND OPERATION OF THE MIRACLE FIELD

WHEREAS, on April 2, 2018, the City of New Albany entered into a ten (10) year ground lease with the New Albany Plain Local Joint Park District to provide for the development and operation of the New Albany Miracle Field; and

WHEREAS, on January 19, 2021, New Albany City Council adopted Resolution R-05-2021 authorizing the city manager to execute the first amendment to said lease and extend the lease from ten (10) years to twenty (20) years; and

WHEREAS, the New Albany Miracle League has requested the city's approval of a second amendment to the lease to facilitate the construction of a building within the boundaries of the existing Miracle Field site that would house restrooms, a concession area with warming kitchen, and a flex space; and

WHEREAS, the Miracle League of New Albany intends to seek the assistance of the Adaptive Sports Connection for the construction of the facility; and

WHEREAS, in order to provide funding for the facility, Adaptive Sports Connection must be added to the lease as a sub-lessee, as is the case with the Miracle League of New Albany.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of New Albany, Counties of Franklin and Licking, State of Ohio, that:

Section 1. The city's ground lease with the New Albany Plain Local Joint Park District shall be amended to include, as a permitted structure, a multi-purpose building that will include restrooms, a concession stand with warming kitchen, and a flex space, the total area of which will be approximately 5,000 square feet.

Section 2. The city's ground lease with the New Albany Plain Local Joint Park District shall also be amended to include Adaptive Sports Connection as a permitted sub-lessee under the previously approved lease terms.

- 3. <u>SECTION 10. SUBLEASE OR ASSIGNMENT</u>: Adaptive Sports Connection is added as an approved Lessee.
